**REPLY MEMORANDUM OF LAW IN SUPPORT OF PLAINTIFF’S REVISED
MOTION FOR ENTRY OF A PRELIMINARY INJUNCTION**

Plaintiff Hong Kong Leyuzhen Technology Co., Ltd. (“Plaintiff”) submits this Reply Memorandum of Law in support of its Revised Motion for Entry of a Preliminary Injunction (the “Reply”).

The Reply is supported by the pleadings and papers on file in this action, the Supplemental Declaration of Shawn A. Mangano, Esq. (the “Supp. Mangano Decl.”), the Declaration of Joseph W. Droter, Esq. (the “Droter Decl.”), the Declaration of Lilly P. O’Dea (the “O’Dea Declaration”), the Supplemental Declaration of Liangjie Li (the “Supp. Li Decl.”), together with the arguments set forth herein and any oral argument by counsel entertained by the Court at the hearing set on this matter.

I. INTRODUCTION

During the May 22, 2024 telephonic hearing in this action, the Court raised two specific issues that it wanted Plaintiff to address in seeking entry of a preliminary injunction: (1) whether the Court to exercise specific personal jurisdiction over the appearing Defendants based on their unauthorized use of copyright protected images on Amazon.com (“Amazon”) storefronts selling counterfeit Rotita brand products; and (2) whether Plaintiff was prepared to thoroughly examine and reduce the amounts currently being restrained in Defendants’ online stores by Amazon to an amount reasonably related to the company’s entitlement to equitable relief through the disgorgement of profits. This Reply seeks to address these concerns directly and succinctly.

Turning first to its concerns over whether personal jurisdiction could be properly exercised over the appearing Defendants, the Court specifically mentioned that many Schedule “A” Defendants often place orders for counterfeit or infringing goods so that there is evidence of purposeful avilment to the jurisdiction. Plaintiff has heeded the Court’s advice and undertook an investigation into online Amazon storefronts using registered copyright protected images and currently unregistered copyright protected images to promote the sale of counterfeit Rotita products. (Supp. Li Decl. ¶ 9, Ex. 1; Droter Decl. ¶¶ 4-20.) This cursory investigation has resulted ten (10) represented Defendants operating online Amazon storefronts displaying unauthorized images owned by Plaintiff and protected by, at least, six (6) individual federal copyright registrations. (*Id.*; Droter Decl. ¶¶ 4-13, 17.) In addition, six (6) more represented Defendants were discovered to be displaying misappropriated, unregistered copyrighted protected images on their Amazon.com online storefronts to advertise the sale of counterfeit Rotita products. (*Id.*; Droter Decl. ¶¶ 4-6, 12, 15-20.) Plaintiff has compiled a summary of these federally registered copyright protected images, their corresponding registration numbers, links to the represented Defendants’

Amazon storefronts displaying these images without authorization, the actual images displayed without authorization, and similar information for the unregistered copyright protected works. (Supp. Li Decl. ¶ 9, Ex. 1.)

After discovering that some sixteen (16) represented Defendants contesting the Court's authority to exercise personal jurisdiction over them and asserting that they had engaged in absolutely no sales to residents of the State of Illinois, Plaintiff used a third party to place multiple orders for counterfeit products using the company's federally registered copyright protected images and unregistered copyright protected images for shipment to Chicago, Illinois. (O'Dea Decl. ¶¶ 4-11; Droter Decl. ¶¶ 4-31.) Each of these purchases, which requested shipment to Chicago, Illinois, resulted in sales confirmation that were captured through screenshots. (*Id.* ¶ 12, Ex. A; Droter Decl. ¶¶ 4, 30, Ex. B.) Moreover, several of these purchases have been shipped and are currently in transit to Chicago, Illinois. (*Id.* ¶ 13, Ex. B; Droter Decl. ¶¶ 31, Ex. C.) In fact, as of the filing of this Reply, at least one counterfeit product offered for sale by a represented Defendant using Rotita's copyright protected images was delivered to Chicago, Illinois. (*Id.* ¶ 14, Ex. C; Droter Decl. ¶¶ 32, Ex. D.)

As such, this Court now has affirmative proof before it that the represented Defendants have engaged in, and continue to engage in, the direct unauthorized copying of Plaintiff's copyright protected images in offering for sale counterfeit Rotita products that can – and now have – been shipped to and received in this judicial district. Under these circumstances, it simply cannot and should not be determined that specific personal jurisdiction cannot be exercised over the represented Defendants. Such a finding would only serve to sanction their ongoing, highly sophisticated counterfeit operation at the expense of Plaintiff's significant intellectual property rights for which it has paid handsomely to secure.

Turning next to the Court’s directive to meaningfully evaluate and reduce the amount of funds currently being restrained by Amazon for each appearing Defendant at the May 22, 2024 telephonic hearing. Plaintiff and its counsel have worked diligently to identify potential, eligible United States sales by the represented Defendants, determine a reasonable net profit rate for those sales, apply that amount to the sums restrained by Amazon, and seek the release of any amount in excess. (Supp. Li Decl. ¶¶ 11-12; Supp. Mangano Decl. ¶ 12, Ex. 1.) In doing so, Plaintiff has identified a 40% net profit rate to be reasonable – particularly given that the represented Defendants use misappropriated advertising images for which Plaintiff is required to pay and given that they also employ the use of the term “Rotita” in their Search Engine Optimization (“SEO”) parameters with Amazon to improperly drive consumer traffic to their counterfeit product storefronts. (Supp. Li. Decl. ¶ 12.) Plaintiff’s counsel has communicated with Defendants’ counsel and relayed the decision to release all amounts restrained by Amazon that do not reasonably support an equitable disgorgement of profits based on the estimated sales figures currently known.¹ (Supp. Mangano Decl. ¶¶ 13-16.) To the extent any other represented Defendants have not been engaged for this discussion, Plaintiff and its counsel are ready and willing to do so. (*Id.* ¶ 18.)

II. ARGUMENT

a. Defendants Are Subject to Specific Personal Jurisdiction.

The answer to this threshold question is crystal clear. The represented Defendants are subject to specific personal jurisdiction.

It is without question that specific personal jurisdiction may properly be exercised over a defendant that has engaged in an online presence, directed to the forum state, that results in order

¹ One exception to this statement is that Plaintiff’s counsel and counsel for the Defendants represented by Michael Adams are negotiating a stipulation to reduce the amounts restrained by Amazon for each of his three clients to \$100,000 per. (Supp. Mangano Decl. ¶ 17.)

and shipment confirmations. *Curry v. Revolution Laboratories, LLC*, 949 F.3d 385, 399 (7th Cir. 2020) (online order and shipping confirmations sufficient for specific jurisdiction). Moreover, even receipt of a single, counterfeit or infringing product in the forum state is sufficient for the exercise of specific personal jurisdiction. *See NBA Properties, Inc. v. HANWJH*, 46 F.4th 614, 624 (7th Cir. 2022).

Here, a vast majority of the represented Defendants have asserted they have made absolutely no sales in the State of Illinois, nor have they adequately targeted the jurisdiction sufficient for specific jurisdiction to be exercised over them. Plaintiff's independent investigation, which could have been more extensive given additional time, revealed that ten (10) of the Represented Defendants were operating additional stores on Amazon.com that used, at least, misappropriated copyright protected images that infringe six (6) federally registered copyrights in connection with the sale of counterfeit Rotita brand products. (Supp. Li Decl. ¶ 9.) Additionally, six (6) more of the Represented Defendants were displaying misappropriated, unregistered copyrighted protected images on their Amazon.com online storefronts to advertise the sale of counterfeit Rotita products. (*Id.*) In sum, Plaintiff has identified the exact same counterfeit operations alleged to have been operating in this case currently operating elsewhere through storefronts maintained by numerous represented Defendants on the Amazon platform.

Not only has Plaintiff identified these parallel, identical, counterfeit sales operations using its copyright protected images as bait for unsuspecting consumers, it has, through a third-party, placed orders for these counterfeit products, received order confirmations in response, been provided access to shipping updates, and has physically received at least one counterfeit product in Chicago, Illinois. (O'Dea Decl. ¶¶ 12-14, Exs. A-C; Droter Decl. ¶¶ 30-32, Exs. B-D.) Given additional time, Plaintiff is confident that it could supply the Court with even more counterfeit

Rotita products received from the represented Defendants' Amazon storefronts once they arrive at their destination in Chicago, Illinois.

In addition to the foregoing facts, the Court is reminded that the Defendants are alleged to be engaged in a highly sophisticated, counterfeit operation in which they are acting in concert and obtaining finished, source products from at least one common supplier. (Supp. Mangano Decl. ¶ 5; Supp, Li Decl. ¶ 7.) Under this scenario, specific personal jurisdiction exercised against one Defendant should be imputed against all Defendants. *See Textor v. Board of Regents of Northern Illinois University*, 711 F.3d 1387, 1392-93 (7th Cir. 1983). To the extent the Court requires Plaintiff to more sufficiently plead these allegations to sustain specific personal jurisdiction on this basis, if deemed necessary, it for entry of the requested injunctive relief subject to doing so. Such relief would preserve the viable basis for Plaintiff's entitlement to injunctive relief while merely conforming the pleadings before the Court to conform with the evidence already presented.

In short, existing caselaw from the Seventh Circuit and from this district supports the exercise of specific personal jurisdiction over Defendants on the record presented. To the extent the Court is somehow unconvinced given the record before it, Plaintiff asks that its request for entry of preliminary injunctive relief be granted while it engages in jurisdictional discovery. To this end, Plaintiff has already made a *prima facie* showing that specific jurisdiction should be exercised over multiple represented and appearing Defendants. *See Central States Pension Fund v. Reimer Express World Corp.*, 230 F.3d 934, 946 (7th Cir. 2000). In this regard, Plaintiff has already requested, and Amazon is already processing, its request for specific sales information related to the State of Illinois that was not provided by the platform in its original responses to the company's expedited discovery. (Supp. Mangano Decl. ¶ 10.) In addition, Plaintiff has set forth other, specifically targeted discovery efforts related to jurisdictional issues with this submission.

(*Id.* ¶ 11.) Accordingly, Plaintiff respectfully requests the Court find that it may properly exercise specific personal jurisdiction over the represented Defendants on the record presented or, alternatively, enter the requested injunctive relief for an interim period while Plaintiff engages in jurisdictional discovery.

b. Plaintiff has Agreed to a Reasonable Release of Restrained Funds, Thereby Further Tipping the Balance of Hardships in Its Favor.

At the May 22, 2024 telephonic hearing, the Court expressed some doubt as to whether the balance of the hardships would sufficiently tip in favor of the Plaintiff in the event funds in excess of any potential equitable disgorgement of profits were restrained. In view of these concerns, the Court directed Plaintiff to meaningfully examine the amounts restrained by Amazon. Plaintiff has heeded the Court's advice and has taken appropriate action.

Specifically, Plaintiff and its counsel have worked to identify a reasonable net profit rate that should be applied to any United States sales by the represented Defendants given the company's net profit rate and advertising expenses, which would likely not apply to Defendants given their use of misappropriated images and the unauthorized incorporation of Plaintiff's "Rotita" brand in their SEO parameters. (Supp. Li Decl. ¶ 12; Supp. Mangano Decl. ¶ 12.) This resulted in Plaintiff identifying a 40% net profit rate for Defendants' accused United States sales. (Supp. Li Decl. ¶ 12.) These accused United States sales, which have been compiled by Plaintiff's use of two proprietary software programs, have been conveyed to its counsel. (*Id.* ¶¶ 11-12.) Counsel used these accused United States sales figures and applied the selected reasonable net profit rate for an equitable disgorgement analysis. (Supp. Mangano Decl. ¶ 12.) If the resulting equitable disgorgement amount exceeded the amount restrained by Amazon, counsel for the Defendant(s) appearing at the May 22, 2024 was advised of the release that would be submitted to

the platform. (Supp. Mangano Decl. ¶ 12-17, Exs. 2-4.) If the disgorgement amount did not exceed the restrained amount, no release would be sought from Amazon. (*Id.* ¶ 12.) The calculations employed in this analysis have been submitted with this Reply. (*Id.*, Ex. 1.) Moreover, Plaintiff remains ready, willing, and able to apply the same analysis to any represented Defendant that it may have inadvertently overlooked. (*Id.* ¶ 18.)

Given the foregoing, Plaintiff submits that it has fully and reasonably addressed the Court's concerns over maintaining asset restrains that exceed the company's potential equitable recovery under a disgorgement of profits analysis. That said, Plaintiff is in the process of communicating with Amazon to facilitate the release of restrained funds and may require a further Order of the Court to effectuate this action based on the platform's requirements. Accordingly, and in view of Plaintiff's actions and representations, the company asserts that the balance of the hardship tips decidedly in its favor, which supports the creation of copyright protected content and the enforcement of such rights.

III. CONCLUSION

For the foregoing reasons, Plaintiff respectfully requests the Court grant its request for entry of a preliminary injunction and maintain the current bond amount required under the TRO, together with issuing any other relief that it deems just and proper.

SUPPLEMENTAL DECLARATION OF SHAWN A. MANGANO, ESQ.
IN SUPPORT OF PLAINTIFF'S REVISED MOTION FOR ENTRY OF A
PRELIMINARY INJUNCTION

I, Shawn A. Mangano, of the City of Las Vegas, in the State of Nevada, declare as follows:

1. Except as otherwise expressly stated to the contrary, this declaration is based upon my personal knowledge of the following facts and, if called as a witness, I could and would competently testify to the statements made herein.

2. I make this declaration in support of Plaintiff's Reply in Support of Motion for Entry of a Preliminary Injunction (the "Reply").

3. I am an attorney at law, duly admitted to practice before the Courts of the State of Illinois and the United States District Court for the Northern District of Illinois. I am one of the attorneys for Plaintiff Hong Kong Leyuzhen Technology Co. Ltd. ("Plaintiff"). I make this declaration from my matters within my own personal knowledge unless stated otherwise.

4. Plaintiff's estimated gross revenue from United States sales likely exceeds \$20,000,000 USD per year. Of this amount, Plaintiff estimates that over \$1,000,000 is derived from sales in the State of Illinois. Moreover, Plaintiff spends anywhere from \$8,000,000 to \$12,000,000 USD each year to specifically advertise its Rotita brand in the United States through such online advertising sources as Google Ads, Facebook, and Bing. Furthermore, the company has spent more than \$80,000 in filing fees paid to the United States Copyright Office just to secure registration of copyright protected works being asserted in eleven (11) enforcement actions initiated in this judicial district. Simply put, Plaintiff is an extremely successful company that earns millions of dollars from product sales in the United States – including within the State of Illinois. To do so, Plaintiff annually spends tens of millions of dollars advertising in the United States to promote the sale of its brand.

5. Plaintiff's operative Complaint in this action is but one piece in a multi-action copyright enforcement campaign that seeks to dismantle a criminal network that operates through six (6) of the largest online retail platforms in existence and includes over 2,500 named Schedule "A" Defendants. These named Schedule "A" Defendants are alleged to be engaged in the practice of copying Plaintiff's copyright protected product images almost instantaneously after they are first displayed on the company's website and then associating these images with sale and promotion of unauthorized, counterfeit products of substandard quality, thereby deceiving consumers – including the citizens of the State of Illinois. Moreover, given the nature of Plaintiff's goods, such large-scale sales operations over multiple online retail platforms require considerable supply chain coordination that could not reasonably be accomplished independently by any of the named Defendants. Accordingly, Defendants are alleged to be operating in concert as part of a large-scale counterfeit operation based in the People's Republic of China.

6. The appearing Defendants in this action argue that the Court cannot reasonably exercise personal jurisdiction over them because they have not engaged in any infringing sales within the State of Illinois. This argument has been raised by those blocks of Defendants represented by Shengmao Mu (the “Mu Defendants”), those represented by Adam Urbanczyk (the “AU Defendants”), and those represented by Benjamin Solter (the “Solter Defendants” and collectively referred to as the “Represented Defendants”) in this action. Only the Mu Defendants (Dkt. No. 66) and AU Defendants (Dkt. No. 55) have filed oppositions to Plaintiff’s Motion for Preliminary Injunction.

7. Defendants have directly targeted their counterfeit sales activities, through online sales platforms not utilized by Plaintiff, in the United States, including to the residents of the State of Illinois, through, at least, fully interactive, e-commerce stores operating under their designated aliases on the Amazon platform.

8. Specifically, Defendants have targeted online sales to Illinois residents by setting up, maintaining, and operating Amazon-based e-commerce stores using their seller aliases that target United States consumers, including residents of the State of Illinois, whereby these targeted sales individuals can purchase counterfeit Rotita brand products.

9. As set forth in the Supplemental Declaration of Liangjie Li submitted in support of Plaintiff’s Reply, Plaintiff performed a cursory investigation for any additional counterfeit products being offered for sale on the Amazon.com platform by any of the Represented Defendants. Plaintiff’s investigation revealed that ten (10) of the Represented Defendants were operating additional stores on Amazon.com that used, at least, misappropriated copyright protected images that infringe six (6) federally registered copyrights in connection with the sale of counterfeit Rotita brand products. The six (6) federally registered copyright registrations are: (1)

VA0002384828; (2) VA0002379888; (3) VA0002379895; (4) VA0002384827; (5) VA0002379893; and (6) VA0002379911. In addition, six (6) more of the Represented Defendants were displaying misappropriated, unregistered copyrighted protected images on their Amazon.com online storefronts to advertise the sale of counterfeit Rotita products. Counterfeit Rotita products from these Represented Defendants' online Amazon storefronts, including those displaying federally registered copyright protected images without authorization, were ordered from Chicago, Illinois, for shipment to Chicago, Illinois. Moreover, purchase confirmations and shipping confirmations have been provided by the Represented Defendants' online storefronts maintained on Amazon.com. Finally, at least one counterfeit product has been physically delivered to Chicago, Illinois as of the filing of this supplemental declaration.

10. Plaintiff has requested Amazon.com provide specific Illinois sales data for the ASINs associated with the Represented Defendants' online storefronts. Amazon is in the process of compiling this specific data. Amazon has not provided a date when its data compilation is expected to be completed.

11. To the extent the Court determines that jurisdictional discovery is necessary at this stage of the proceedings, Plaintiff would expect to receive the requested Illinois-specific sales data for the ASINs associated with the Represented Defendants' online storefronts, it would expect to subpoena any third-party data services responsible for tracking the Represented Defendants' online sales and reviews to identify any sales made in the State of Illinois, it would expect to send out written discovery requests to the Represented Defendants on jurisdictional discovery topics, and it may elect to depose principals associated with, at least, the major identified sellers of counterfeit products on jurisdictional issue that are represented by counsel in this action.

12. Plaintiff has provided me with a list of United States product sales by the Represented Defendants and all other Defendants that, to the best of my recollection, appeared at the last hearing in this matter. I have compiled a chart that summarizes each Defendant block by their counsel. The chart next includes the identified United States sales made by each Defendant, the amount of funds frozen by Amazon.com, and an estimated equitable disgorgement of profits from each Defendant based on the 40% net profit margin identified by Plaintiff's Chief Operating Officer in his supporting declaration. (Supp. Li Decl. ¶ 12.) I have then included this disgorgement of profits estimate in a separate column. If the amount frozen by Amazon.com exceeded the disgorgement of profits estimate, the difference has been targeted for release by the platform. If the amount frozen by Amazon.com was less than the disgorgement of profits estimate, then a release of funds is not appropriate. Attached as Exhibit "1" is a true and correct copy of my Amazon fund release analysis spreadsheet created for this action.

13. I have attempted to negotiate the release of funds per the Court's directive at the last telephonic hearing in this matter. To the best of my knowledge, I have contacted counsel for the Represented Defendants and all other Defendants appearing at that hearing

14. I have advised counsel for the Mu Defendants the amounts being targeted for release for each qualifying Defendant via email on June 3, 2024. Attached as Exhibit "2" is a true and correct copy of my June 3, 2024 email to counsel for the Mu Defendants.

15. I have advised counsel for the Solter Defendants the amounts being targeted for release for each qualifying Defendant via email on June 3, 2024. Attached as Exhibit "3" is a true and correct copy of my June 3, 2024 email to counsel for the Solter Defendants.

16. I have advised counsel for the AU Defendants the amounts being targeted for release for each qualifying Defendant via email on June 3, 2024. Attached as Exhibit “4” is a true and correct copy of my June 3, 2024 email to counsel for the AU Defendants.

17. In addition, I have exchanged emails with Michael Adams, Esq. concerning the release of funds frozen by Amazon.com for his three clients. At this time, we are negotiating a stipulated resolution whereby funds in the amount of \$100,000 per Defendant would be frozen.

18. Plaintiff remains ready, will, and able to employ the same analysis in seeking the release of funds currently frozen by Amazon.com for any other represented Defendant in this action that contacts counsel.

I declare under penalty of perjury under the laws of the United States of America the foregoing is true and correct.

As set forth in the Supplemental Declaration of Liangjie Li submitted in support of Plaintiff's Reply, Plaintiff performed a cursory investigation for any additional counterfeit products being offered for sale on the Amazon.com platform by any of the Represented Defendants. Plaintiff's investigation revealed that ten (10) of the Represented Defendants were operating additional stores on Amazon.com that used, at least, misappropriated copyright protected images that infringe six (6) federally registered copyrights in connection with the sale of counterfeit Rotita brand products. The six (6) federally registered copyright registrations are: (1) VA0002384828; (2) VA0002379888; (3) VA0002379895; (4) VA0002384827; (5) VA0002379893; and (6) VA0002379911. In addition, six (6) more of the Represented Defendants were displaying misappropriated, unregistered copyrighted protected images on their Amazon.com online storefronts to advertise the sale of counterfeit Rotita products. Counterfeit Rotita products from these Represented Defendants' online Amazon storefronts, including those displaying federally registered copyright protected images without authorization, were ordered from Chicago, Illinois, for shipment to Chicago, Illinois. Moreover, purchase confirmations and shipping confirmations have been provided by the Represented Defendants' online storefronts maintained on Amazon.com. Finally, at least one counterfeit product has been physically delivered to Chicago, Illinois as of the filing of this supplemental declaration.

**SUPPLEMENTAL DECLARATION OF LIANGJIE LI
IN SUPPORT OF PLAINTIFF'S REPLY IN SUPPORT OF REVISED MOTION FOR
PRELIMINARY INJUNCTION**

I, Liangjie Li, of Hong Kong, a special administrative region of the People's Republic of China, declare as follows:

1. Except as otherwise expressly stated to the contrary, this declaration is based upon my personal knowledge of the following facts and, if called as a witness, I could and would competently testify to the statements made herein.

2. I make this supplemental declaration in support of Plaintiff's Reply in Support of Revised Motion for Entry of a Preliminary Injunction (the "Reply").

3. I am the Chief Operations Officer for Plaintiff Hong Kong Leyuzhen Technology Co. Ltd. ("Plaintiff"). I make this declaration from my matters within my own personal knowledge unless stated otherwise.

4. Plaintiff markets and sells women's clothing and related items under the "Rotita" brand name ("Rotita").

5. Rotita is an extremely well-known source of women's clothing in the United States and has been the subject of rampant counterfeit sales through online platforms such as Amazon, Walmart, Aliexpress, eBay, Walmart, and Alibaba. These are the six largest online retailers in the World – and Plaintiff does not sell its products through any one of them. Rather, Plaintiff only sells its genuine Rotita brand products through its website rotita.com.

6. Plaintiff's rough estimated gross revenue from United States sales likely exceeds \$20,000,000 USD per year. Of this amount, Plaintiff roughly estimates that over \$1,000,000 is derived from sales in the State of Illinois. Moreover, Plaintiff spends roughly anywhere from \$8,000,000 to \$12,000,000 USD each year to specifically advertise its Rotita brand in the United States through such online advertising sources as Google Ads, Facebook, and Bing. Furthermore, the company has spent more than \$80,000 in filing fees paid to the United States Copyright Office just to secure registration of copyright protected works being asserted in eleven (11) enforcement actions initiated in this judicial district. Simply put, Plaintiff is an extremely successful company that earns millions of dollars from product sales in the United States – including within the State of Illinois. To do so, Plaintiff annually spends tens of millions of dollars advertising in the United States to promote the sale of its brand.

7. The defendants named in the company's copyright infringement enforcement actions are engaged in the practice of copying Plaintiff's copyright protected product images almost instantaneously after they are first displayed on the company's website and then associating these images with sale and promotion of unauthorized, counterfeit products of substandard quality, thereby deceiving consumers – including the citizens of the State of Illinois. Moreover, given the

nature of Plaintiff's goods, such large-scale sales operations over multiple online retail platforms require considerable supply chain coordination that could not reasonably be accomplished independently by any of the named Defendants. Accordingly, Defendants are believed to be acting in concert as part of a larger counterfeit products syndicate.

8. Defendants have directly targeted their counterfeit sales activities, through online sales platforms not utilized by Plaintiff, in the United States, including to the residents of the State of Illinois, through, at least, fully interactive, e-commerce stores operating under their designated aliases on the Amazon platform.

9. Defendants in this action have continued to sell counterfeit Rotita brand products on Amazon.com. Plaintiff performed a cursory investigation for any additional counterfeit products being offered for sale on the Amazon.com platform by any of the Represented Defendants. Plaintiff's investigation revealed that ten (10) of the Represented Defendants were operating additional stores on Amazon.com that used, at least, misappropriated copyright protected images that infringe six (6) federally registered copyrights in connection with the sale of counterfeit Rotita brand products. In addition, six (6) more of the Represented Defendants were displaying misappropriated, unregistered copyrighted protected images on their Amazon.com online storefronts to advertise the sale of counterfeit Rotita products. Attached as Exhibit "1" is a true and correct copy of a document summarizing the copyright registration numbers owned by Plaintiff, the copyright protected images, the link to Defendant's infringing image being used to sell counterfeit products on Amazon.com, and a picture of the unauthorized, copyright image being displayed on Defendants' online store fronts. Exhibit "1" also contains a list of the same information for the unregistered, copyright protected works owned by Plaintiff.

10. Plaintiff has secured the services of two proprietary software programs capable of tracking the online sales activity for those offering identified products through Amazon and other related online platforms. This has resulted in nothing short of startling results. For instance, where a majority of the currently appearing Defendants have claimed zero infringing sales, Plaintiff's employment of the proprietary software products has revealed that Defendants have likely sold in far excess of \$10,000,000 in counterfeit Rotita brand products.

11. Plaintiff has provided its counsel with a copy of the search results for United States sales for each of the Defendants appearing through counsel in this case.

12. Plaintiff expects to earn a net profit of approximately 30% on the sale of its Rotita brand products. This figure, however, includes substantial advertising expenses that Defendants would not have to pay since they are largely capitalizing on Plaintiff's advertising efforts by misappropriating its copyright protected images and imbedding the term "Rotita" in their Amazon.com search engine optimization. Doing so causes their online stores to be displayed whenever someone searches for "Rotita" on Amazon.com despite Plaintiff not selling authentic "Rotita" brand products on the platform. Based on the foregoing, I would estimate that Defendants' online stores operate at a net profit of between 40% to 50%. I believe that a disgorgement of Defendants' profits would fall within the net profit range.

I declare under penalty of perjury under the laws of the United States of America the foregoing is true and correct.




