DEFAULT JUDGMENT

Because the defendants listed below have failed to plead or otherwise defend, and because the plaintiff has shown that failure by affidavit, the Court hereby enters default judgment for the plaintiff pursuant to Fed. R. Civ. P. 55(b)(2), as follows:

1. The Court finds, by the admission of liability by virtue of the default, that the defendants have reproduced the plaintiff's copyrighted photographs by using the photographs on the defendants' respective websites in connection with the marketing of the defendants' respective products. The Court further finds the defendant's conduct to be willful as the defendant knew that it did not create or own the copyrighted photographs but chose to use them anyway. Given the plaintiff's interest in protecting its intellectual property, to include the ability to license that intellectual property on its own terms, the Court finds the harm irreparable. Further

the Court finds the public interest served by enforcement of the copyright laws outweighs any harm to the defendant, who has no right to the copyrighted works.

2. Based on these findings, the defendants, their officers, agents, servants, employees, and attorneys are permanently enjoined from reproducing the plaintiff's copyrighted photographs registered as VA0002379894.

3. Pursuant to 17 U.S.C. § 504(c), the Court awards statutory damages to the plaintiff in the amount of \$15,000 as to each defendant based on each defendant's willful infringement.

4. Any third-party currently restraining the defendants' assets, including PayPal, Alipay, Alibaba, Ant Financial, Wish.com, and Amazon Pay, shall turnover any monies currently restrained in the defendant's account—up to the amount of statutory damages awarded in the preceding paragraph—to the plaintiff within fourteen business days. Once done, any prior asset restraint entered in this case as to these defendants is rescinded.
