PRELIMINARY INJUNCTION ORDER

Plaintiff Hong Kong Leyuzhen Technology Co. Limited ("Leyuzhen") filed a Motion for Entry of a Preliminary Injunction against the fully interactive, e-commerce stores operating under the seller aliases identified in Schedule A to the Complaint and attached hereto (collectively, "Defendants") and using at least the online marketplace accounts identified in Schedule A (the "Online Marketplaces"). After reviewing the Motion and the accompanying record, this Court GRANTS Leyuzhen's Motion in part as follows.

This Court finds Leyuzhen has provided notice to Defendants in accordance with the Temporary Restraining Order entered December 16, 2024, ECF No. 15 ("TRO"), and Federal Rule of Civil Procedure 65(a)(1).

This Court also finds, in the absence of adversarial presentation, that Leyuzhen has provided a basis to conclude that Defendants have sold products bearing unauthorized copies of Leyuzhen's federally registered copyrights (the "Leyuzhen Copyrights").

This Court also finds that the injunctive relief previously granted in the TRO should remain in place through the pendency of this litigation and that issuing this Preliminary Injunction is warranted under Federal Rule of Civil Procedure 65. Evidence submitted in support of this Motion and in support of Leyuzhen's previously granted Motion for Entry of a TRO establishes that Leyuzhen has demonstrated a likelihood of success on the merits; that no remedy at law exists; and that Leyuzhen will suffer irreparable harm if the injunction is not granted.

Specifically, Leyuzhen has proved a *prima facie* case of copyright infringement because it has demonstrated that (1) Leyuzhen is the owner of the valid and enforceable Leyuzhen Copyrights, and (2) Defendants, without any authorization from Leyuzhen, or any right under the law, have deliberately copied, displayed, distributed, reproduced, and/or made derivate works incorporating the Leyuzhen Copyrights. Furthermore, Defendants' continued and unauthorized use of the Leyuzhen Copyrights irreparably harms Leyuzhen through diminished goodwill and brand confidence, damage to Leyuzhen's reputation, loss of exclusivity, and loss of future sales. Monetary damages fail to address such damage and, therefore, Leyuzhen has an inadequate remedy at law. Moreover, the public interest is served by entry of this Preliminary Injunction to dispel the public confusion created by Defendants' actions. Accordingly, this Court orders that:

1. Defendants, their officers, agents, servants, employees, attorneys, and all persons acting for, with, by, through, under, or in active concert with them be preliminarily enjoined and restrained from:

- a. reproducing, distributing copies of, making derivative works of, or publicly displaying the Leyuzhen Copyrights in any manner without the express authorization of Leyuzhen;
- b. committing any acts calculated to cause consumers to believe that Defendants' products are those sold under the authorization, control, or supervision of Leyuzhen, or are sponsored by, approved by, or otherwise connected with Leyuzhen; and
- c. manufacturing, shipping, delivering, holding for sale, transferring or otherwise moving, storing, distributing, returning, or otherwise disposing of, in any manner, products or inventory not manufactured by or for Leyuzhen, nor authorized by Leyuzhen to be sold or offered for sale, and which bear any of Leyuzhen's copyrights, including the Leyuzhen Copyrights, or any reproductions, counterfeit copies, or colorable imitations.
- 2. Defendants shall not transfer or dispose of any money or other of Defendants' assets in any of Defendants' financial accounts.
- 3. Upon Leyuzhen's request, Defendants and any third party with actual notice of this Order who is providing services for any of Defendants, or in connection with any of Defendants' Online Marketplaces, including, without limitation, any online marketplace platforms such as eBay, Inc., AliExpress, Alibaba Group Holding Ltd. ("Alibaba"), Amazon.com, Inc., ContextLogic Inc. d/b/a Wish.com ("Wish.com"), and Dhgate (collectively, the "Third Party Providers"), shall, within seven (7) calendar days after receipt of such notice, provide to Leyuzhen expedited discovery, limited to copies of documents and records in such person's or entity's possession or control sufficient to determine:

- a. the identities and locations of Defendants, their officers, agents, servants, employees, attorneys, and any persons acting in active concert or participation with them, including all known contact information and all associated e-mail addresses;
- b. the nature of Defendants' operations and all associated sales, methods of payment for services, and financial information, including, without limitation, identifying information associated with the Online Marketplaces and Defendants' financial accounts and Defendants' sales and listing history related to their respective Online Marketplaces; and
- c. any financial accounts owned or controlled by Defendants, including their officers, agents, servants, employees, attorneys, and any persons acting in active concert or participation with them, including such accounts residing with or under the control of any banks, savings and loan associations, payment processors or other financial institutions, including, without limitation, PayPal, Inc. ("PayPal"), Alipay, Wish.com, Alibaba, Ant Financial Services Group ("Ant Financial"), Amazon Pay, or other merchant account providers, payment providers, third party processors, and credit card associations (e.g., MasterCard and VISA).
- 4. Upon Leyuzhen's request, those with notice of this Order, including the Third Party Providers as defined in Paragraph 3, shall within seven (7) calendar days after receipt of such notice, disable and cease displaying any advertisements used by or associated with Defendants in connection with the sale of counterfeit and infringing goods bearing the Leyuzhen Copyrights.

- 5. Any Third Party Providers, including PayPal, Alipay, Alibaba, Ant Financial, Wish.com, and Amazon Pay, shall, within seven (7) calendar days of receipt of this Order:
 - a. locate all accounts and funds connected to Defendants' seller aliases, including, but
 not limited to, any financial accounts connected to the information listed in
 Schedule A hereto, the e-mail addresses provided for Defendants by third parties;
 and
 - b. restrain and enjoin any such accounts or funds from transferring or disposing of any money or other of Defendants' assets until further order by this Court.
- 6. Leyuzhen may provide notice of the proceedings in this case to Defendants, including service of process pursuant to Fed. R. Civ. P. 4(f)(3), and any future motions, by electronically publishing a link to the Pleadings, this Order, and other relevant documents on a website and by sending an e-mail with a link to said website to the e-mail addresses provided for Defendants by third parties. The Clerk of the Court is directed to issue a single original summons in the name of "CHAOLILAI and all other Defendants identified in the Operative Complaint" that shall apply to all Defendants. The combination of providing notice via electronic publication and e-mail, along with any notice that Defendants receive from payment processors, shall constitute notice reasonably calculated under all circumstances to apprise Defendants of the pendency of the action and afford them the opportunity to present their objections.
- 7. Any Defendants that are subject to this Order may appear and move to dissolve or modify the Order as permitted by and in compliance with the Federal Rules of Civil Procedure

and the Northern District of Illinois Local Rules. Any third party impacted by this Order may move for appropriate relief.

8. The \$24,000 bond posted by Leyuzhen shall remain with the Court until a final disposition of this case or until this Preliminary Injunction is terminated.
