COMPLAINT

Plaintiff, Wumei Lin (“Plaintiff”), hereby files its Complaint for damages and injunction relief for copyright infringement against HONG KONG JIBI LIMITED dba Gkfxvkq (the “Defendant”) attached as **Exhibit 2** and in support of its claims states as follows:

NATURE OF THE ACTION

1. Plaintiff is a professional photographer who licenses his photographic works to clothing companies for commercial use in advertising and marketing.

2. Plaintiff is the owner of all rights, title, and interest in and to United States Copyright Registration VA 2-412-626 for a Group of Published Photographs, registration issued pursuant to 37 C.F.R. Section 202.4(i). (“Plaintiff’s Copyright Registration”). Plaintiff’s Copyright Registration attached hereto as **Exhibit 1**. This registration was issued for a specific photo published from February 26, 2024, to April 19, 2024. *Id.* Plaintiff’s Copyright Registration contains a group of photographs referred to as Women’s Swimwear 2024. *Id.*

3. In the case at bar, this Defendant is a business entity operating at least one online storefront (“Online Stores”) on the Temu Platform, who has infringed on Plaintiff’s Copyright Registration by its unauthorized and unlicensed continuous use of Plaintiff’s copyrighted Photo

from Plaintiff's Women's Swimwear 2024 without authorization to promote and sell products derived from Plaintiff's photos, which Plaintiff specifically licenses his photos to manufacturers for their use to create products from ("Plaintiff's Copyrighted Photo," the "Copyrighted Photo"). Plaintiff's Photographic Infringement Evidence attached hereto as **Exhibit 2**.

4. Plaintiff has never licensed to this Defendant for any use of the Plaintiff's Copyrighted Photo, nor is this Defendant otherwise authorized to display the photo.

5. This Defendant's unlawful use of Plaintiff's Copyrighted Photo on the Temu Platform deprives Plaintiff of licensing revenue, undermines his ability to issue exclusive licenses, and causes irreparable harm to his livelihood and reputation.

6. This Defendant causes mass harm to Plaintiff, an individual, by causing him to lose his source of income and control over his lawfully owned Copyrighted Photos.

JURISDICTION AND VENUE

7. This Court has original subject matter jurisdiction over the claims in this action pursuant to the provisions of the Federal Copyright Act, 17 U.S.C. § 101, et seq., 28 U.S.C. § 1338(a)–(b) and 28 U.S.C. § 1331.

8. This Court may exercise personal jurisdiction over this Defendant because this Defendant directly targets business activities towards consumers specifically in Illinois, through their systematic and continuous use of Plaintiff's Copyrighted Photo on its fully interactive commercial Online Stores on the Temu Platform, identified in **Exhibit 3**.

9. This Defendant has targeted sales to the United States by operating this e-commerce stores, which cater to United States consumers, offers shipping to the United States, including specifically here Illinois, accept payment in U.S. dollars, and sells products using unauthorized and unlicensed copies Plaintiff's Copyrighted Photo.

10. In this case, this Defendant copies and displays Plaintiff's Copyrighted Photo without license or authorization specifically to residents of Illinois through the Temu Platform.

11. Upon information and belief, this Defendant is a foreign entity with sufficient contacts with this forum state, as it has systematically and continuously used Plaintiff's Copyrighted Photo for commercial purposes in this judicial district. This systematic and continuous unauthorized and unlicensed use of Plaintiff's Copyrighted Photo throughout the United States, and in our case Illinois, for commercial purposes makes it reasonably foreseeable that this Defendant would be hauled in a court in Illinois. The exercise of jurisdiction in this Court complies with due process.

12. Venue is proper in this district under 28 U.S.C. § 1391 because this Defendant is subject to this Court's personal jurisdiction and this Defendant, based on a pre-suit investigation, is not a resident of the United States. This Defendant is engaging in infringing activities and causing harm within the Northern District of Illinois by displaying Plaintiff's Copyrighted Photo for commercial purposes within the district, and advertising, offering to sell, selling, and/or shipping products to consumers in this district.

THE PARTIES

Plaintiff

13. Plaintiff is the owner of the Copyrighted Photo, attached as **Exhibit 2**.

14. Plaintiff owns all rights, including, without limitation, the rights to reproduce the Copyrighted Photo in copies, prepare derivative works based upon the copyrighted works, and distribute copies of the Copyrighted Photo to the public by sale or other transfer of ownership, or by rental, lease, or lending the Copyrighted Photo. **Exhibit 1**.

15. Plaintiff licenses his Copyrighted Photo to clothing suppliers so they can use them to market their products.

16. Plaintiff earns his livelihood by licensing his works, through the exclusive licenses to fashion brands.

17. Plaintiff has issued exclusive licenses over his Copyrighted Photo involved in this suit.

18. Loss of exclusivity and control over this Copyrighted Photo creates serious harm to Plaintiff, who relies on limiting the availability of the Copyrighted Photo to sustain its value.

19. Unauthorized use by this Defendant destroys exclusivity, devalues Plaintiff's Copyrighted Photos, and diminishes future licensing opportunities.

20. Plaintiff has neither licensed nor authorized this Defendant to use the Copyrighted Photo.

21. Plaintiff's focus in his Copyrighted Photo is the photographing of articles of clothing and models wearing the attire that the licensees distribute.

22. If Plaintiff were to allow the continued distribution of the Defendant's products through the use Plaintiff's Copyrighted Photo, and not enforce its licensing, Plaintiff's artwork would become devalued in that:

- a. it prevents Plaintiff's Copyrighted Photo from being exclusively used by the licensees of this photo to make their high-quality products appear distinct; and
- b. it shows future licensees that buying a license from Plaintiff comes with no guarantee of exclusivity.

23. Plaintiff's livelihood depends on the ability to control the exclusivity of the licensing of his Copyrighted Photos, which the swarm of illicit actors makes incredibly difficult,

while simultaneously devaluing Plaintiff's Copyrighted Photos every day Plaintiff lacks control over them.

24. The damage to Plaintiff and Plaintiff's Copyright Registration from this Defendant's systematic use of Plaintiff's Copyrighted Photo and its profiting from the sale of products through their continuous use of and infringement of Plaintiff's Copyrighted Photo is imminent, irreparable, and unquantifiable.

Defendant

25. Defendant is an individual and/or business entity of unknown corporate organization and/or structure, who owns and/or operates HONG KONG JIBI LIMITED doing business as, at least, Gkfxvkq storefront on the Temu Platform, located at RM 01, 26TH FLOOR, WORKING VIEW COMM BUILDING, 21 YIU WAH STREET, CAUSEWAY BAY HONG KONG Wan Chai 999077 Hong Kong Special Administrative Region, Hong Kong Island China. Attached hereto as **Exhibit 3** are web captures of Defendant's infringing activities.

26. It is believed this Defendant reside and/or operate in foreign jurisdictions outside the United States.

27. This Defendant conducts business across the United States, including in this judicial district of Illinois, through its systematic and continuous use of Plaintiff's Copyrighted Photo within the operation of its Online Stores. **Exhibits 2 and 3**. This Defendant has offered to sell and have sold products using illicit copies of Plaintiff's original Copyrighted Photo without permission. See **Exhibit 2** for links to infringing uses of the copyrights on the Defendant's Online Stores.

28. The Temu Platform allows business entities to set up multiple online stores using a variety of seller alias store names. The Temu platform also typically do not require sellers to reveal

their actual business entities on the main storefronts, enabling infringers to set up multiple profiles and stores that seem unrelated but are actually controlled by the same individuals.

DEFENDANT' UNLAWFUL CONDUCT

29. The quality of Plaintiff's work and the brands he licenses his work to have attracted many illicit infringers who copy and display unauthorized and unlicensed copies of Plaintiff's Copyrighted Photo to sell products of the clothing depicted in Plaintiff's Copyrighted Photo.

Exhibit 2.

30. Upon information and belief, this Defendant has full knowledge or should have known of Plaintiff's ownership and authorship of the Copyrighted Photo lawfully registered to Plaintiff under the registration number VA 2-412-626. **Exhibit 1.**

31. Plaintiff seeks to shut down this Defendant's Online Stores, where this Defendant display copies, they made of Plaintiff's Copyrighted Photo without permission.

32. Fraudulent seller alias registration patterns are among the common tactics used by Internet store operators, such as this Defendant, to conceal their identities and the full extent of their illicit activities, and to avoid shutdown.

33. This Defendant's intentionally use this gamesmanship tactic of hiding behind various seller aliases to obstruct enforcement aimed to stop their ongoing infringement activities.

34. Upon information and belief, this Defendant, operates multiple credit card merchant accounts and third-party accounts, hidden behind layers of payment gateways, enabling defendants to continue their operations despite the pending enforcement actions.

35. Upon information and belief, this Defendant maintains offshore bank accounts and regularly transfer funds from its Online Stores and the associated accounts to offshore banks outside this Court's jurisdiction.

36. Notable features stand out to this Defendant's Online Stores includes the identical or nearly identical copy of Plaintiff's Copyrighted Photo containing the Women's Tankini from the 2024 swimswear subject matter is displayed throughout its Online Store, the tankini product is identically or similarly priced, the webpage contains similar sales discounts, and customer reviews as Plaintiff's authorized licensees.

37. This Defendant's use of Plaintiff's Copyrighted Photo devalues Plaintiff's Copyright Registration by eliminating and diluting the exclusiveness of the copyrights Plaintiff has been lawfully issued by the U.S. Copyright Office and continues to hold the rights of the same today. **Exhibit 1.**

38. This Defendant, unless restrained temporarily, preliminarily, and permanently enjoined by this Court, their ongoing and continuous infringement of Plaintiff's Copyrighted Photo for commercial purposes will continue to cause irreparable harm to Plaintiff and Plaintiff's Copyright Registration.

COUNT I
COPYRIGHT INFRINGEMENT (17 U.S.C. § 101, et seq.)

39. Plaintiff repeats, realleges, and incorporates by reference herein its allegations contained in paragraphs 1 through 38, above.

40. Plaintiff's Copyrighted Photo has substantial value and was produced and created at significant expense.

41. Plaintiff owns all exclusive rights, including the rights to reproduce the photo, license the Copyrighted Photo for copies, create derivative works based on copyright registrations, and to distribute the Copyrighted Photo to the public through sale, transfer of ownership, rental, lease, or lending. **Exhibit 1.**

42. This Defendant systematically and continually uses Plaintiff's Copyrighted Photo to sell its goods for commercial purposes throughout the United States, and specifically here into Illinois.

43. This Defendant's unauthorized use of Plaintiff's Copyrighted Photo, for commercial purposes, on its Online Stores, constitutes copyright infringement.

44. Plaintiff is entitled to receive the profits made by this Defendant from its wrongful acts, under 17 U.S.C. § 504(b). This Defendant should be required to provide an itemized financial account for all sales, gains, profits, and advantages derived by this Defendant from its copyright infringement.

45. Plaintiff is entitled to and may elect to choose injunctive relief under 17 U.S.C. § 502, enjoining any use or exploitation of the Copyright Photo by this Defendant.

46. Plaintiff had to hire and agree to compensate at a reasonable rate the undersigned firm; therefore, Plaintiff seeks and is also entitled to recover reasonable attorneys' fees and costs of suit under 17 U.S.C. § 505.

47. Plaintiff has no adequate remedy at law, and, if this Defendant's actions are not enjoined, Plaintiff will continue to suffer immediate and irreparable harm to his reputation and Plaintiff's Copyrighted Photo due to this loss of exclusivity which will devalue his portfolio and future ability to license his work.

48. Reputational damage and the devaluation of one's future works cannot be remedied by monetary damages. Instead, they are irreparable injuries lacking adequate remedies at law, without an injunction.

49. Under 17 U.S.C. §§502 and 503, Plaintiff is entitled to injunctive relief prohibiting this Defendant from further displaying Plaintiff's Copyrighted Photo, ordering that this Defendant

destroy all unauthorized copies, Defendant's copies, plates, and other embodiments of the copyrighted works from which copies can be reproduced, if any, should be impounded and forfeited to Plaintiff as instruments of infringement, and all infringing copies created by Defendant should be impounded and forfeited to Plaintiff, under 17 U.S.C §503.

50. In addition to actual damages, Plaintiff is entitled to and may elect to choose statutory damages under 17 U.S.C. § 504(c), which should be enhanced by 17 U.S.C. § 504(c)(2) because of this Defendant's willful copyright infringement.

51. On information and belief, this Defendant's infringing acts are willful, deliberate, and committed with prior notice and knowledge of Plaintiff's Copyrighted Photo.

52. Defendant either knew, or should have known, that Plaintiff's Copyrighted Photo was registered with the Copyright Office, as it did not create them independently and should have reasonably discovered ownership before displaying it. **Exhibit 1.**

53. As a direct and proximate result of this Defendant's unauthorized and infringing conduct, this Defendant has obtained and continues to gain sales, profits, and other benefits rightfully belonging to Plaintiff, which this Defendant would not otherwise have but for its ongoing infringement of Plaintiff's Copyrighted Photo.

54. These acts by this Defendant are willful, intentional, ongoing and continuous. Therefore, this Defendant should be held jointly and severally liable for its infringement actions on Plaintiff's Copyrighted Registrations.

55. Accordingly, Plaintiff seeks an award of damages under 17 U.S.C. § 504 U.S.C. § 504(c), which should be enhanced by 17 U.S.C. § 504(c)(2).

PRAYER FOR RELIEF

WHEREFORE, Plaintiff prays for judgment against this Defendant as follows:

1. This Defendant, any additional affiliates, their officers, agents, servants, employees, attorneys, confederates, and all persons acting for, with, by, through, under, or in active concert with them be temporarily, preliminarily, and permanently enjoined and restrained from:

a. using Plaintiff's Copyrighted Photo or any reproductions, counterfeit copies, or colorable imitations thereof in any manner in connection with the distribution, marketing, advertising, offering for sale, or sale of any product that is not authorized by Plaintiff to be sold in connection with Plaintiff's Copyrighted Photo under Plaintiff's Copyright Registration;

b. further infringing on the Plaintiff's Copyright Registration and damaging Plaintiff's reputation and goodwill;

c. using, linking to, transferring, selling, exercising control over, or otherwise owning this Defendant's stores on the Defendant's Online Stores or the Temu Platform, or any other domain name or online marketplace account that is being used to sell or is the means by which this Defendant could continue to conduct commercial activity using Plaintiff's Copyrighted Photo; and

d. operating and/or hosting websites at this Defendant's online stores and any other domain names registered or operated by this Defendant that are involved with the distribution, marketing, advertising, offering for sale, or sale of any product through the unauthorized use of the Plaintiff's Copyrighted Photo.

2. That this Defendant, within fourteen (14) days after service of judgment with notice of entry thereof upon it, be required to file with the Court and serve upon Plaintiff a written report under oath setting forth in detail the manner and form in which this Defendant has complied with paragraph 1 above.

3. Entry of an Order that, upon Plaintiff's request, those in privity with this Defendant and those with notice of the injunction, including in our case here the Temu Platform, as well as AliExpress, Walmart, Amazon, DHgate, eBay, Temu, and Wish, social media platforms such as Facebook, YouTube, Instagram, Temu, LinkedIn, X, Internet search engines such as Google, Bing and Yahoo, web hosts for this Defendant's Online Stores, and domain name registrars ("Third Party Providers"), shall:

a. disable and cease providing services for any accounts through which this Defendant engage in commercial activity using Plaintiff's Copyrighted Photo, including any accounts associated with this Defendant;

b. disable and cease displaying any advertisements used by or associated with Defendant that displays Plaintiff's Copyrighted Photo; and

c. take all necessary steps to prevent links to this Defendant's Online Stores from displaying in search results, including, but not limited to, removing links to this Defendant's domain names from any search index.

4. That this Defendant account for and pay to Plaintiff all profits realized by them through the unauthorized use of Plaintiff's Copyrighted Photo.

5. In the addition to actual damages, Plaintiff be awarded statutory damages of not less than \$750 and not more than \$30,000 for every infringement of the Copyrights under 17 U.S.C. § 504(c), which should be enhanced to a sum of not more than \$150,000 by 17 U.S.C. § 504(c)(2) because of this Defendant's willful copyright infringement.

6. Plaintiff be awarded its reasonable attorneys' fees and costs.

7. Award any and all other relief that this Court deems just and proper.

DEMAND FOR JURY TRIAL

Plaintiff also demands a trial by jury of all issues so triable pursuant to Federal Rule of Civil Procedure 38.
