**SEALED ORDER ON PLAINTIFF'S *EX PARTE* APPLICATION  
FOR ENTRY OF TEMPORARY RESTRAINING ORDER AND ORDER  
RESTRAINING TRANSFER OF ASSETS**

**THIS CAUSE** is before the Court the Renewed *Ex Parte* Application for Entry of Temporary Restraining Order Including a Temporary Asset Restraint, and Expedited Discovery (the "Application") filed by Plaintiff, Hong Kong Leyuzhen Technology Co. Limited, ("Plaintiff") under 17 U.S.C. § 102 et seq., including 17 U.S.C. § 501, Fed. R. Civ. P. 65, and The All Writs Act, 28 U.S.C § 1651(a), and this Court's inherent authority. ECF No. [25].

Defendants are the individuals, business entities, and unincorporated associations identified in Schedule "A" hereto (the "Defendants"). Plaintiff asks the Court to enter (1) a temporary restraining order against Defendants, and (2) an order restraining the financial accounts used by Defendants. Upon due consideration of the

Application, the pertinent portions of the record, the relevant authorities, and for the reasons set forth herein, the Application is hereby **GRANTED**.

**I. FACTUAL BACKGROUND**

The following factual background is taken from Plaintiff's Complaint, ECF No. [1], the Application, and supporting evidentiary submissions and exhibits.

Plaintiff claims it is the owner of all rights, title, and interest in and to the copyright registrations issued by the United States Copyright Office for specific images related to its Rotita brand product line, which is used in connection with the promotion and sale of women's apparel, (the "Rotita Copyright"). See Declaration of Liangjie Li (the "Li Decl."). The Rotita Copyright at issue are the following bear the following federal registration numbers: VA0002369378, VA0002379881, VA0002379888, VA0002379895, VA0002379897, VA0002379907, VA0002379911, VA0002379930, VA0002380492, VA0002381840, VA0002381842, VA0002384827, VA0002384829, VA0002386556, VA0002413181, VA0002413183, VA0002413187, VA0002413190, VA0002413196, and VA0002413197. ECF No. [25] at 2.

Plaintiff alleges that Defendants, by operating the Internet based e-commerce stores under the seller names listed on Schedule "A" hereto (the "E-commerce Store Names"), have advertised, promoted, marketed, distributed, offered for sale, or sold goods bearing and/or using what Plaintiff has determined to be counterfeits, infringements, reproductions and/or colorable imitations of the Rotita Copyright. *Id.*

Plaintiff further claims it has ordered sample products from each of the Defendants to ensure that the products listed in connection with the Display of Plaintiff's copyright protected photographs could be ordered and delivered to

consumers in Florida. See Declaration of William R. Brees (“Brees Decl.”). Specifically, Anisah Beaston, on behalf of Plaintiff, placed product orders on the online Amazon platform from each Defendant, and confirmed that each Defendant’s online stores were displaying Plaintiff’s federally registered copyrights to promote advertise, market, distribute, offer for sale, and sell competing products matching the subject matter of the Rotita Copyright. See Declaration of Anisah Beaston (“Beaston Decl.”).

On May 8, 2025, Plaintiff filed its Complaint against Defendants for copyright infringement and violations under FDUPTA. ECF No. [1]. On June 3, 2025, Plaintiff filed its first *Ex Parte* Motion for Temporary Restraining Order, Including a Temporary Asset Restraint and Expedited Discovery, ECF No. [10], which this Court denied at ECF No. [19]. On September 22, 2025, Plaintiff filed the instant Application. ECF No. [25].

## **II. LEGAL STANDARD**

To obtain a temporary restraining order, a party must demonstrate “(1) a substantial likelihood of success on the merits; (2) that irreparable injury will be suffered if the relief is not granted; (3) that the threatened injury outweighs the harm the relief would inflict on the non-movant; and (4) that the entry of the relief would serve the public interest.” *Schiavo ex. rel Schindler v. Schiavo*, 403 F.3d 1223, 1225–26 (11th Cir. 2005).

Additionally, Federal Rule of Civil Procedure 65 provides that a court may only issue a temporary restraining order without notice to the adverse party or its attorney if:

- (A) specific facts in an affidavit or a verified complaint clearly show that immediate and irreparable injury, loss, or damage will result to the movant before the adverse party can be heard in opposition; and
- (B) the movant's attorney certifies in writing any efforts made to give notice and the reasons why it should not be required.

Fed. R. Civ. P. 65(b)(1). *Ex parte* temporary restraining orders “should be restricted to serving their underlying purpose of preserving the status quo and preventing irreparable harm just so long as is necessary to hold a hearing, and no longer.” *Granny Goose Foods, Inc. v. Bhd. of Teamsters & Auto Truck Drivers Local No. 70*, 415 U.S. 423, 439 (1974).

### **III. CONCLUSIONS OF LAW**

The declarations Plaintiff submitted in support of its Application support the following conclusions of law:

Plaintiff has a strong probability of proving at trial that consumers are likely to be confused by Defendants' advertisement, promotion, sale, offer for sale, or distribution of goods bearing and/or using counterfeits, reproductions, or colorable imitations of the Rotita Copyright, and that the products Defendants are selling and promoting for sale are copies of Plaintiff's products that bear and/or use copies of the Rotita Copyright, and that the infringement of the Rotita Copyright will likely cause Plaintiff to suffer immediate and irreparable injury if a Temporary Restraining Order is not granted.

The following specific facts, as set forth in Plaintiff's Complaint, the Application, and accompanying declarations, demonstrate that immediate and irreparable loss, damage, and injury will result to Plaintiff and consumers before

Defendants can be heard in opposition unless Plaintiff's request for *ex parte* relief is granted:

(1) Defendants own or control Internet based e-commerce stores operating under their seller names which advertise, promote, offer for sale, and sell products bearing and/or using infringing images/products in violation of Plaintiff's rights;

(2) there is good cause to believe that more infringing products bearing and/or using Plaintiff's copyright will appear in the marketplace, that consumers are likely to be misled, confused, or disappointed by the quality of these products, and that Plaintiff may suffer loss of sales for its genuine products; and

(3) there is good cause to believe that if Plaintiff proceeds to put Defendants on notice of this Application, Defendants can easily and quickly change the ownership or modify e-commerce store data and content, redirect consumer traffic to other e-commerce store names, change payment accounts, and transfer assets and ownership of the E-commerce Store Names, thereby thwarting Plaintiff's ability to obtain meaningful relief.

The potential harm to Defendants in restraining their trade in infringing branded goods if a temporary restraining order is issued is far outweighed by the potential harm to Plaintiff, its reputation, and its goodwill as a manufacturer and distributor of quality products if such relief is not issued.

The public interest favors issuance of the temporary restraining order to protect Plaintiff's copyright interests and protect the public from being defrauded by the illegal sale of counterfeit goods. Further, under Section 504 of Title 17, Plaintiff may be entitled to recover, as an equitable remedy, the illegal profits gained through

Defendants' distribution and sales of goods bearing and/or using infringements of the Rotita Copyright. *See Reebok Int'l, Ltd. v. Marnatech Enters., Inc.*, 970 F.2d 552, 559 (9th Cir. 1992) (quoting *Fuller Brush Prods. Co. v. Fuller Brush Co.*, 299 F.2d 772, 777 (7th Cir. 1962) ("An accounting of profits under § 1117(a) is not synonymous with an award of monetary damages: '[a]n accounting for profits . . . is an equitable remedy subject to the principles of equity.'")).

Requesting equitable relief "invokes the district court's inherent equitable powers to order preliminary relief, including an asset freeze, in order to assure the availability of permanent relief." *Levi Strauss & Co. v. Sunrise Intern. Trading Inc.*, 51 F.3d 982, 987 (11th Cir. 1995) (citing *FTC v. U. S. Oil & Gas Corp.*, 748 F.2d 1431, 1433-34 (11th Cir. 1984), *abrogated on other grounds by AMG Cap. Mgmt., LLC v. FTC*, 593 U.S. 67, 70 (2021)).

In light of the inherently deceptive nature of the infringing business, and the likelihood that Defendants have violated federal copyright laws, Plaintiff has good reason to believe Defendants will hide or transfer their ill-gotten assets beyond the jurisdiction of this Court unless those assets are restrained.

Accordingly, upon due consideration of Plaintiff's Complaint, Application, and supporting evidentiary submissions, it is hereby **ORDERED AND ADJUDGED** that pursuant to 17 U.S.C. § 102 *et seq.*, including 17 U.S.C. § 501, Federal Rule of Civil Procedure 65, 28 U.S.C. §1651(a), and the Court's inherent authority, Plaintiff's Application, ECF No. [25], is **GRANTED**, according to the terms set forth below:

#### **TEMPORARY RESTRAINING ORDER**

1. Each Defendant, its officers, directors, employees, agents, subsidiaries,

distributors, and all persons in active concert or participation with any Defendant having notice of this Order are hereby temporarily restrained as follows:

a. From using, displaying, manufacturing, importing, advertising, promoting, offering to sell, selling, distributing, or transferring any products bearing and/or using the Rotita Copyright; and

b. From secreting, concealing, destroying, selling off, transferring, or otherwise disposing of: (i) any products, not manufactured or distributed by the Plaintiff, bearing and/or using the Rotita Copyright, or any confusingly similar copyright; (ii) any evidence relating to the manufacture, importation, sale, offer for sale, distribution, or transfer of any products bearing and/or using the Rotita Copyright, or any confusingly similar copyrights; or (iii) any assets or other financial accounts subject to this Order, including inventory assets, in the actual or constructive possession of, or owned, controlled, or held by, or subject to access by, any Defendant, including, but not limited to, any assets held by or on behalf of any Defendant.

2. Each Defendant, its officers, directors, employees, agents, subsidiaries, distributors, and all persons in active concert or participation with any Defendant having notice of this Order shall immediately discontinue the use of the Rotita Copyright or any confusingly similar copyrights, on or in connection with all e-commerce stores owned and operated, or controlled by them, including the Internet based e-commerce stores operating under the E-commerce Store Names.

3. Each Defendant, its officers, directors, employees, agents, subsidiaries, distributors, and all persons in active concert or participation with any Defendant

having notice of this Order shall immediately discontinue the use of the Rotita Copyright, or any confusingly similar copyrights within domain name extensions, metatags or other markers within website source code, from use on any webpage (including as the title of any web page), from any advertising links to other websites, from search engines' databases or cache memory, and any other form of use of such terms that are visible to a computer user or serves to direct computer searches to e-commerce stores registered, owned, or operated by any Defendant, including the Internet based e-commerce stores operating under the E-commerce Store Names.

4. Each Defendant shall preserve copies of all computer files relating to the use of any of the E-commerce Store Names and shall take all steps necessary to retrieve computer files relating to the use of the E-commerce Store Names that may have been deleted before the entry of this Order.

5. Upon receipt of notice of this Order, Defendants and all financial institutions, payment processors, banks, escrow services, money transmitters, or marketplace platforms, including but not limited to, Temu.com ("Temu"), PayPal Inc. ("PayPal"), Alipay, ContextLogic Inc. d/b/a Wish.com ("Wish"), Alibaba Group Holding Ltd. ("Alibaba"), Ant Financial Services Group ("Ant Financial"), Amazon Pay, Afterpay, Klarna or other merchant account providers, payment providers, third party processors, and credit card associations (e.g., MasterCard and VISA) (each, a "Third Party," and collectively, the "Third Parties") shall immediately (i) identify all financial accounts and/or sub-accounts, associated with the Internet based e-commerce stores operating under the E-commerce Store Names, payees, merchant identification numbers, financial accounts, and/or the e-mail addresses identified on

Schedule "A" hereto, as well as any other related accounts of the same customer(s); (ii) identify all other accounts which transfer funds into the same financial institution account(s) or any of the other financial accounts subject to this Order; (iii) restrain the transfer of all funds, as opposed to ongoing account activity, held or received for their benefit or to be transferred into their respective financial accounts, and any other financial accounts tied thereto; and (iv) divert those restrained funds to a holding account for the trust of the Court. By no later than **five days** prior to the expiration of the Temporary Restraining Order as set forth herein, Plaintiff shall file a notice (which may be submitted under seal) advising the Court of the total amount of funds so restrained from each of the Defendants.

6. Upon receipt of notice of this Order, Defendants and all financial institutions, payment processors, banks, escrow services, money transmitters, or marketplace platforms, including but not limited to, the Third Parties, and their related companies and affiliates, shall further, **within five business** days of receiving notice of this Order, provide Plaintiff's counsel with all data that details (i) an accounting of the total funds restrained and identify the financial account(s) and sub-account(s) which the restrained funds are related to, and (ii) the account transactions related to all funds transmitted into the financial account(s) and sub-account(s) which have been restrained. Such restraining of the funds and the disclosure of the related financial institution account information shall be made without notice to the account owners or the financial institutions until after those accounts are restrained. No funds restrained by this Order shall be transferred or surrendered by any financial institution, payment processor, bank, escrow service, money transmitter, or

marketplace website, including but not limited to, eBay, and their related companies and affiliates for any purpose (other than pursuant to a purchase refund chargeback made by a consumer) without the express authorization of this Court. By no later than **five days** prior to the expiration of the Temporary Restraining Order as set forth herein, Plaintiff shall file a notice (which may be submitted under seal) attaching a copy of all data received pursuant to this paragraph.

7. Any Defendant or Third Party subject to this Order may petition the Court to modify the asset restraint set out in this Order.

8. This Order shall apply to the E-commerce Store Names, associated e-commerce stores, and financial accounts, and any other e-commerce store names, or financial accounts which are being used by Defendants for the purpose of counterfeiting the Rotita Copyright and/or unfairly competing with the Plaintiff.

9. As a matter of law, this Order shall no longer apply to any Defendant or associated e-commerce store name dismissed from this action or as to which Plaintiff has withdrawn its request for a temporary restraining order.

10. This Order shall remain in effect for **fourteen days** from the date of its entry unless extended for good cause.

#### **BOND TO BE POSTED**

11. Pursuant to Section 1116(d)(5)(D) of Title 15, United States Code, and Federal Rule of Civil Procedure 65(c), by no later than **five business days** from the date of this Order, Plaintiff shall post a bond in the amount of **Ten Thousand Dollars and Zero Cents (\$10,000.00)**, as payment of damages to which Defendants may be entitled for a wrongful injunction or restraint, during the pendency of this

action, or until further Order of the Court. In the Court's discretion, the bond may be subject to increase should an application be made in the interest of justice. Plaintiff shall file a notice with the Court to confirm its compliance with this provision.

12. Plaintiff shall post copies of the Complaint, the Application, this Order, as well as all other documents filed in this action on the website located at <http://blointernetenforcement.com/> and shall provide the address to the website to Defendants via e-mail/online contact form, and such notice so given shall be deemed good and sufficient service thereof. Plaintiff shall continue to provide notice of the documents on file in this matter to Defendants by regularly updating the website located at <http://blointernetenforcement.com/>, or by other means reasonably calculated to give notice which is permitted by the Court.

13. Additionally, for the purpose of providing additional notice of this proceeding and all other pleadings, orders, and documents filed herein, the owners, operators and/or administrators of the e-commerce stores, and/or Third Parties, including but not limited to, PayPal, and their related companies and affiliates, shall, at Plaintiff's request, provide Plaintiff's counsel with any contact information and all associated e-mail addresses known to be associated with Defendants' respective E-commerce Store Names.


14. Unless stated otherwise herein, Defendants shall have **five business days** to comply with this Temporary Restraining Order following notice.

15. Upon Plaintiff's request, those with notice of this Order, including the Third-Parties, shall within **seven calendar days** after receipt of such notice, disable and cease displaying any advertisements used by or associated with

Defendants in connection with the sale of infringing goods using the Plaintiff's  
Copyright.

The Clerk shall file this Order under seal until further order of the Court.
