Plaintiff makes this motion on the grounds that the Defendants have failed to appear or otherwise respond to the Complaint within the time prescribed by Federal Rules of Civil Procedure.

On January 21, 2026, the Court authorized electronic service via email on Defendants listed in Schedule "A" [Dkt. No. 8]. On March 31, 2026, Defendants were served with the Summons and copies of the Complaint, the Order Granting the Motion for Alternative Service, and the Temporary Restraining Order via electronic mail ("e-mail") to the email addresses provided by the Platform in response to the request for expedited discovery as permitted by the TRO and via

website posting pursuant to the Court's Order authorizing alternate service of process. (Declaration of Willam Brees attached hereto (the "Brees Decl.") ¶¶ 3, 4; see Dkt. No. 13 Return of Service on file with the Court). The deadline to respond to the Complaint and Jury Demand (the "Complaint") [Dkt. No.1] was April 21, 2026, Brees Decl. at ¶ 6.

Pursuant to Federal Rule of Civil Procedure 12(a)(1)(A), the Defendants had twenty-one (21) days to answer or otherwise respond to Plaintiff's Complaint in this action. As of the filing of this Motion, twenty-three (23) days have expired since electronic service was effectuated on the Schedule "A" Defendants. *Id.* at ¶ 8. To date, none of the Defendants have answered or otherwise responded to Plaintiff's Complaint. *Id.* at ¶ 9.

WHEREFORE, Plaintiff request that default be entered against the Defendants.
