ELECTRONIC SERVICE AND EXPEDITED DISCOVERY ORDER

Plaintiff Hong Kong Leyuzhen Technology Co. Limited (“PLAINTIFF”) filed a Motion for Service by Publication, Electronic Service and Expedited Discovery (the “Motion”) against The Individuals, Corporations, Limited Liability Companies, Partnerships and Unincorporated Associations identified in Schedule A, attached as Exhibit 2 to Plaintiff’s Complaint, (“Defendants”). After reviewing the Motion and the accompanying documents, this Court GRANTS PLAINTIFF’s Motion as follows:

Plaintiff is the owner of certain Copyright-Protected Photographs under the federal Copyright Registration Numbers; VA0002379881, VA0002379888, VA0002379893, VA0002379895, VA0002379911, VA0002379930, VA0002380492, VA0002381840, VA0002382273, VA0002384827, VA0002384838, VA0002384843, VA0002413181, and VA0002413196, attached as Exhibit 1 attached to Plaintiff’s Complaint [Dkt. Nos. 1-1 and 2].

Accordingly, this Court Orders as follows:

1. PLAINTIFF is authorized to issue expedited written discovery to Defendants, pursuant to Federal Rules of Civil Procedure 33, 34, 36, and 45 related to:

- a. the identities and locations of Defendants, its officers, agents, servants, employees, attorneys, and any persons acting in active concert or participation with them, including all known contact information and all associated e-mail addresses;
- b. the nature of Defendants' operations and all associated sales, methods of payment for services, and financial information, including, without limitation, identifying information associated with the Online Marketplaces and Defendants' financial accounts, including Defendants' sales and listing history related to their respective Online Marketplaces; and
- c. any financial accounts, assets, or other resources owned or controlled by Defendants, including their officers, agents, servants, employees, attorneys, and any persons acting in active concert or participation with them, including such accounts residing with or under the control of any banks, savings and loan associations, payment processors or other financial institutions, including, without limitation, SHEIN, PayPal, Inc. ("PayPal"), Alipay, ContextLogic Inc. d/b/a Wish.com ("Wish.com"), Alibaba Group Holding Ltd. ("Alibaba"), Ant Financial Services Group ("Ant Financial"), Amazon Pay, TikTok Shop or other merchant account providers, payment providers, third party processors, and credit card associations (e.g., MasterCard and VISA).

2. Upon PLAINTIFF's request, any third party with actual notice of this Order who is providing services for any of the Defendants, or in connection with any of Defendants' Online Marketplaces, including, without limitation, any online marketplace platforms such as


DHGate, eBay Inc., AliExpress, Temu, Amazon.com Inc., Wish.com, Alibaba and TikTok (collectively the “Third Party Providers”), shall, within seven (7) calendar days after receipt of such notice, provide to PLAINTIFF expedited discovery, limited to copies of documents and records in such person’s or entity’s possession or control sufficient to determine:

- a. the identities and locations of Defendants, its officers, agents, servants, employees, attorneys, and any persons acting in active concert or participation with them, including all known contact information and all associated e-mail addresses;
- b. the nature of Defendants’ operations and all associated sales, methods of payment for services, and financial information, including, without limitation, identifying information associated with the Online Marketplaces and Defendants’ financial accounts, including Defendants’ sales and listing history related to its respective Online Marketplaces; and
- c. any financial accounts owned or controlled by Defendants, including its officers, agents, servants, employees, attorneys, and any persons acting in active concert or participation with them, including such accounts residing with or under the control of any banks, savings and loan associations, payment processors or other financial institutions, including, without limitation, DHGate, SHEIN, PayPal, Alipay, Wish.com, Alibaba, Ant Financial, Amazon Pay, Payoneer, TikTok Shop, Walmart, Temu, or other merchant account providers, payment providers, third party processors, and credit card associations (e.g., MasterCard and VISA).

3. PLAINTIFF may provide notice of the proceedings in this case to Defendants, including service of process pursuant to Fed. R. Civ. P. 4(f)(3), and any future motions, by electronically publishing a link to the Complaint, this Order, and other relevant documents on a

website and by sending an e-mail with all the relevant documents attached to any e-mail addresses provided for Defendants by third parties. The Clerk of the Court is directed to issue a single original summons in the name of “The Individuals, Corporations, Limited Liability Companies, Partnerships and Unincorporated Associations Identified in Schedule A,” that shall apply to all Defendants. The combination of providing notice via electronic publication and e-mail, along with any notice that Defendants receive from payment processors, shall constitute notice reasonably calculated under all circumstances to apprise Defendants of the pendency of the action and afford them the opportunity to present their objections.
