ELECTRONIC SERVICE AND EXPEDITED DISCOVERY ORDER

Plaintiff WUMEI LIN (“PLAINTIFF”), filed a Motion for Alternative Service by Electronic Mail and Expedited Discovery (the “Motion”) against the fully interactive, e-commerce stores¹ operating under the domain names identified in Schedule A to the Complaint and attached hereto (collectively, “Defendants”) and using at least the online marketplace accounts identified in Schedule A (the “Online Marketplaces”). After reviewing the Motion and the accompanying documents, this Court GRANTS PLAINTIFF’s Motion as follows:

The Court finds that Plaintiff has good cause to conduct early discovery because without discovery Plaintiff is unable to identify defendants allegedly using and displaying without authorization Plaintiff’s federally registered copyrights (the “Plaintiff’s Copyrights”) (Docket No. 1-1), Exhibit 1 to the Complaint, VA0002405791, VA0002420078, VA0002421806, and VA0002365588.

Accordingly, this Court Orders as follows:

1. PLAINTIFF is authorized to issue expedited written discovery to Defendants, pursuant to Federal Rules of Civil Procedure 33, 34, 36, and 45 related to:

- a. the identities and locations of Defendants, their officers, agents, servants, employees, attorneys, and any persons acting in active concert or participation with them, including all known contact information and all associated e-mail addresses; and
- b. the Defendants' sales and listing history related to their respective Online Marketplaces;

2. Upon PLAINTIFF's request, any third party with actual notice of this Order who is providing services for any of the Defendants, or in connection with any of Defendants' Online Marketplaces, including, without limitation, any online marketplace platforms such as TikTok, eBay Inc., AliExpress, Temu, Amazon.com Inc., Wish.com, and Dhgate (collectively the "Third Party Providers"), shall, within seven (7) calendar days after receipt of such notice, provide to PLAINTIFF expedited discovery, limited to copies of documents and records in such person's or entity's possession or control sufficient to determine:

- a. the identities and locations of Defendants, their officers, agents, servants, employees, attorneys, and any persons acting in active concert or participation with them, including all known contact information and all associated e-mail addresses; and
- b. Defendants' sales and listing history related to their respective Online Marketplaces.

3. PLAINTIFF may provide notice of the proceedings in this case to Defendants, including service of process pursuant to Fed. R. Civ. P. 4(f)(3), and any future motions, by sending an e-mail, with the documents being served attached to the email, to any e-mail addresses provided for Defendants by third parties. The Clerk of the Court is directed to issue a single original summons in the name of "THE INDIVIDUALS, CORPORATIONS, LIMITED LIABILITY

COMPANIES, PARTNERSHIPS, AND UNINCORPORATED ASSOCIATIONS IDENTIFIED IN SCHEDULE A HERETO” that shall apply to all Defendants. The combination of providing notice via e-mail, along with any notice that Defendants receive from payment processors, shall constitute notice reasonably calculated under all circumstances to apprise Defendants of the pendency of the action and afford them the opportunity to present their objections.
