***SEALED* TEMPORARY RESTRAINING ORDER**

Plaintiff WUMEI LIN (“Plaintiff”) filed an *Ex Parte* Renewed Motion for Entry of a Temporary Restraining Order and Other Relief (the “Motion”) against the fully interactive, e-commerce stores operating under the seller aliases identified in Schedule A to the First Amended Complaint [Dkt. 15-2] and attached hereto (collectively, “Defendants”). After reviewing the Motion and the accompanying record, this Court GRANTS Plaintiff’s Motion as follows.

The Court finds that the Copyrighted Photographs for United States Copyright Registration Nos. VA0002422590, VA0002465286, VA0002465414, and VA0002421830 (the “Copyrighted Photographs”) are the subject of valid United States Copyright Registrations owned by Daning Zhou, and that Plaintiff Wumei Lin holds rights in the Copyrighted Photographs, including the right to commercially license and sublicense the works and to enforce those rights against unauthorized third-party use.

This Court finds, in the absence of adversarial presentation, that it has personal jurisdiction over Defendants because Defendants directly target their business activities toward consumers in

the United States, including Illinois. Specifically, Plaintiff has provided a basis to conclude that Defendants have targeted sales to Illinois residents by setting up and operating fully interactive online e-commerce stores that target United States consumers using one or more seller aliases, offer shipping to the United States, including Illinois, and have sold products through the use of unauthorized and unlicensed reproductions of the Copyrighted Photographs to residents of Illinois. In this case, Plaintiff has presented screenshot evidence that each online Defendant e-commerce store is reaching out to do business with Illinois residents, by operating one or more commercial, interactive internet stores through which Illinois residents can and do purchase products from listings displaying unlicensed and unauthorized reproductions of the Copyrighted Photographs. *See* Docket No. 19, which shows that Plaintiff's counsel has purchased products from the infringing listings to their offices located in Illinois.

This Court also finds that issuing this Order without notice pursuant to Rule 65(b)(1) of the Federal Rules of Civil Procedure is appropriate as Plaintiff has presented specific facts through the Declarations of Katherine M. Kuhn, Anisah Beaston, Wumei Lin, and Daning Zhou in support of the Motion and supporting evidence which clearly show immediate and irreparable injury, loss, and damage will result to Plaintiff before the adverse party can be heard in opposition. Specifically, in the absence of an *ex parte* Order, Defendants could and likely would move any assets from accounts in financial institutions under this Court's jurisdiction to unidentifiable offshore accounts. Accordingly, this Court orders that:

1. Defendants, their officers, agents, servants, employees, attorneys, and all persons acting for, with, by, through, under, or in active concert with them, be temporarily enjoined and restrained from using the Copyrighted Photographs subject of Copyright Registration Nos. VA0002422590, VA0002465286, VA0002465414, and VA0002421830 for a Group of

Published Photographs, registration issued pursuant to 37 C.F.R. Section 202.4(i), including any reproductions, digital copies, print copies, photocopies, colorable imitations, replicas, simulations, mockups, in any format, either physical print or in digital formatting, in connection or relation with the distribution, supply, sharing, reproduction, manufacturing, mass production, drop shipping, marketing, advertising, making, offering for sale, or sale of any products that is not a genuine product of Plaintiff's or not authorized by Plaintiff to be sold in connection with the Copyrighted Photographs;

2. Defendants shall not transfer, move, relocate, or dispose of any assets in any accounts associated with the seller aliases identified in Schedule A.
3. Upon Plaintiff's request, those with notice of this Order, including the Third-Party Providers as defined in Paragraph 5, shall within seven (7) calendar days after receipt of such notice, disable and cease displaying any advertisements used by or associated with the unlicensed and unauthorized use of the Copyrighted Photographs.
4. Any Third-Party Providers, including Amazon, TikTok Shop, PayPal, Alipay, Alibaba, Ant Financial, Wish.com, and Amazon, shall, within seven (7) calendar days of receipt of this Order:
 - a. locate all accounts and funds connected to Defendants' seller aliases, including, but not limited to, any financial accounts connected to the information listed in Schedule A, including any e-mail addresses provided for Defendants by third parties; and
 - b. restrain and enjoin any such accounts or funds from transferring, disposing, relocating, assigning, moving, or any other method of shifting any of the said

money or any other asset or resource of these Defendants until further ordered by this Court, or until the expiration of this court Order, whichever occurs first.

5. Plaintiff may provide notice of the proceedings in this case to the Defendants, including notice of the preliminary injunction hearing and service of process pursuant to Fed. R. Civ. P. 4(f)(3), and any future motions, by electronically publishing a link to the Complaint, this Order, and other relevant documents on a website and by sending an e-mail with those documents attached and with a link to said website to the e-mail addresses identified and provided for Defendants by third parties.
6. The Clerk of the Court is directed to issue a single original summons in the name of “Huneny Womens Summer Clothes and all other Defendants identified in the First Amended Complaint” that shall apply to all Defendants. The combination of providing notice via electronic publication and e-mail, along with any notice that Defendants receive from payment processors, shall constitute notice reasonably calculated under all circumstances to apprise Defendants of the pendency of the action and afford them the opportunity to present their objections.
7. Plaintiff must provide notice to Defendants of any motion for preliminary injunction as required by Rule 65(a)(1).
8. Plaintiff shall deposit with the Court Ten Thousand Dollars and Zero Cents (\$10,000.00) either cash or surety bond, as security, which amount has, in the absence of adversarial testing, been deemed adequate for the payment of such damages as any person may be entitled to recover as a result of a wrongful restraint hereunder.
9. Any Defendants that are subject to this Order may appear and move to dissolve or modify the Order as permitted by and in compliance with the Federal Rules of Civil Procedure and

the Northern District of Illinois Local Rules. Any third party impacted by this Order may move for appropriate relief.

10. This Temporary Restraining Order without notice is entered at 9:00 A.M. on this 14th day of April 2026 and shall remain in effect for fourteen (14) calendar days. Any motion to extend this Order must be filed by April 23, 2026.
