FINAL DEFAULT JUDGMENT ORDER

This action having been commenced by Plaintiff, HONG KONG LEYUZHEN TECHNOLOGY CO., LTD. (“Plaintiff”) against Defendant, bymayberry.com (“Defendant”) as alleged in the Complaint, (“Defendant’s Internet Store” and “Website”), and Plaintiff having moved for entry of Default Judgment against the Defendant (the “Defaulting Defendant” and “Defendant”).

Plaintiff having properly completed service of process on Defaulting Defendant, the combination of providing notice via electronic publication or e-mail, being notice reasonably calculated under all circumstances to apprise Defaulting Defendant of the pendency of the action and affording them the opportunity to answer and present their objections; and

The Defaulting Defendant having not answered in any way, and the time for answering having expired, so that the allegations of the First Amended Complaint are uncontroverted and are deemed admitted;

THIS COURT HEREBY FINDS that it has personal jurisdiction over Defaulting Defendant because Defaulting Defendant directly targets their business activities toward

consumers in the United States, including Illinois. Specifically, Plaintiff has provided a basis to conclude that Defaulting Defendant has targeted sales to Illinois residents by setting up and operating an e-commerce store that targets United States consumers using one or more seller aliases, offers shipping to the United States, including Illinois, and has sold products using infringing versions of Plaintiff's federally registered copyright, which are protected by U.S. Copyright Registration Nos. VA0002379881, VA0002379894, VA0002379895, VA0002379897, VA0002381117, VA0002381840, VA0002413196, VA0002413494, VA0002414218, VA0002414223, VA0002414332, VA0002415182, VA0002416206, VA0002416231, VA0002416248, VA0002416896, VA0002417354, VA0002436262, VA0002436255 and VA0002438935 (the "Copyright Protected Photographs") to residents of Illinois. In this case, Plaintiff has presented screenshot evidence that Defendant's e-commerce store is reaching out to do business with Illinois residents by operating one or more commercial, interactive internet stores through which Illinois residents can purchase products using infringing versions of the Copyright Protected Photographs [Dkt No. 1-2], which includes screenshot evidence confirming that Defendant's e-commerce store does stand ready, willing, and able to ship their unauthorized goods to customers in Illinois using infringing versions of the Copyright Protected Photographs, with a completed purchase and sale to Illinois. [Dkt. No. 1-2].

THIS COURT FURTHER FINDS that Defaulting Defendant is liable for direct federal copyright infringement (17 U.S.C. § 504).

Accordingly, this Court orders that Plaintiff's Motion for Entry of Default and Default Judgment is GRANTED as follows, that Defaulting Defendant is deemed in default, and that this Default Final Judgment is entered against Defaulting Defendant.

THIS COURT FURTHER ORDERS that:

1. Defaulting Defendant, their officers, agents, servants, employees, attorneys, and all persons acting for, with, by, through, under, or in active concert with them be permanently enjoined and restrained from:

- a. using the Copyright Protected Photographs or any reproductions, infringing copies, or colorable imitations in any manner in connection with the distribution, marketing, advertising, offering for sale, or sale of any product that is not a genuine Rotita product or not authorized by Plaintiff to be sold in connection with the Copyright Protected Photographs;
- b. passing off, inducing, or enabling others to sell or pass off any product as a genuine Rotita product or any other product produced by Plaintiff, that is not Plaintiff's or not produced under the authorization, control, or supervision of Plaintiff and approved by Plaintiff for sale under the Copyright Protected Photographs;
- c. committing any acts calculated to cause consumers to believe that Defaulting Defendant's products are those sold under the authorization, control, or supervision of Plaintiff, or are sponsored by, approved by, or otherwise connected with Plaintiff; and
- d. manufacturing, shipping, delivering, holding for sale, transferring or otherwise moving, storing, distributing, returning, or otherwise disposing of, in any manner, products or inventory not manufactured by or for Plaintiff, nor authorized by Plaintiff to be sold or offered for sale, and which bear any of Plaintiff's copyrights, including the Copyright Protected Photographs, or any reproductions, infringing copies or colorable imitations.

2. Defaulting Defendant and any third party with actual notice of this Order who is providing services for the Defaulting Defendant, or in connection with any of the Defaulting Defendant's Internet Store, including, without limitation, any online marketplace platforms such as Shopify, PayPal, Payoneer, GoDaddy Operating Company, LLC, Godaddy, LLC, SHEIN, eBay, Inc., AliExpress, Alibaba, Amazon.com, Inc., Wish.com, TikTok Shop, Walmart, Temu, NameCheap Inc. and Dhgate and collectively referred to as the "Third Party Providers", shall within seven (7) calendar days of receipt of this Order cease:

- a. using, linking to, transferring, selling, exercising control over, or otherwise owning the Defendant's Internet Store(s), or any other online marketplace account that is being used to sell or is the means by which Defaulting Defendant could continue to sell infringing goods using the Copyright Protected Photographs; and
- b. operating and/or hosting websites that are involved with the distribution, marketing, advertising, offering for sale, or sale of any product bearing the Copyright Protected Photographs or any reproductions, infringing copies or colorable imitations thereof that is not a genuine Rotita product or not authorized by Plaintiff to be sold in connection with the Copyright Protected Photographs.

3. Upon Plaintiff's request, those with notice of this Order, including the Third-Party Providers as defined in Paragraph 2, shall within seven (7) calendar days after receipt of such notice, disable and cease displaying any advertisements used by or associated with Defaulting Defendant in connection with the sale of infringing goods using the Copyright Protected Photographs.

4. Pursuant to 17 U.S.C. § 504(c)(2), Plaintiff is awarded statutory damages against the Defaulting Defendant in the amount of (\$300,000.00) for the willful infringement of the Twenty (20) Copyrights asserted in the Complaint.

5. Any Third Party Providers holding funds for Defaulting Defendant, including Shopify, PayPal, Payoneer, GoDaddy Operating Company, LLC, Godaddy LLC, SHEIN, eBay, Inc., AliExpress, Alibaba, Amazon.com, Inc., Wish.com, TikTok Shop, Walmart, Temu, NameCheap Inc. and Dhgate, shall, within seven (7) calendar days of receipt of this Order, permanently restrain and enjoin any accounts connected to Defaulting Defendant or the Defendant's Internet Store from transferring or disposing of any funds (up to the statutory damages awarded in Paragraph 4 above) or other of Defaulting Defendant's assets.

6. All monies (up to the amount of the statutory damages awarded in Paragraph 4 above), currently or in the future, restrained in Defaulting Defendant's financial accounts, including monies held by Third Party Providers such as Temu, TikTok, Payoneer, Amazon, Walmart, PayPal, Alibaba, and WISH, are hereby released to Plaintiff as partial payment of the above-identified damages, and Third Party Providers, such as Temu, Payoneer, Amazon, Walmart, Alibaba, Tiktok, and WISH, are ordered to release to Plaintiff the amounts from Defaulting Defendant's financial accounts within fourteen (14) calendar days of receipt of this Order.

7. The domain name registries for the Defendant Domain Names, including, but not limited to, VeriSign, Inc., Neustar, Inc., Afilias Limited, CentralNic, Nominet, and the Public Interest Registry, and the domain name registrars, including, but not limited to, GoDaddy Operating Company LLC, Name.com, PDR LTD. dba PublicDomainRegistry.com, and Namecheap Inc., within seven (7) calendar days of receipt of this Order, shall, at Plaintiff's choosing:

- a. transfer the Defendant Domain Name to Plaintiff's control, including unlocking and changing the registrar of record for the Defendant Domain Name to a registrar of Plaintiff's selection, and the Domain name registrars shall take any steps necessary to transfer the Defendant's Domain Name to a registrar of Plaintiff's selection; and/or
- b. disable the Defendant's Domain Names and make them inactive and untransferable.

8. Until Plaintiff has recovered full payment of monies owed to it by any Defaulting Defendant, Plaintiff shall have the ongoing authority to commence supplemental proceedings under Federal Rule of Civil Procedure 69.

9. In the event that Plaintiff identifies any additional online marketplace accounts or financial accounts owned by Defaulting Defendant, Plaintiff may send notice of any supplemental proceeding, including a citation to discover assets, to Defaulting Defendant by e-mail at any e-mail addresses provided for Defaulting Defendant by third parties.

10. The One Thousand Dollars (\$1,000) surety bond posted by Plaintiff is hereby released to Plaintiff or its counsel, Bayramoglu Law Offices, LLC, 1540 West Warm Springs Road, Suite 100, Henderson, NV 89014. The Clerk of the Court is directed to return the surety bond previously deposited with the Clerk of the Court to the Plaintiff or its counsel.

This is a Final Default Judgment.
